ON THE STATEMENT ON THE PROPERTY STATUS OF THE BANK MANAGEMENT AND SUPERVISORY  
BOARD MEMBERS**

**Article 1**

Article 4 of the Decision on the property statement of the bank management and supervisory board members ("Official Gazette of Republika Srpska" No. 116/17) shall be amended and read as follows:

"The content of the statement and data on the property status of the persons referred to in Article 2 of this Decision are set out in Annex 1, which shall be published on the official website of the Agency."

**Article 2**

Article 5, Paragraph 3 of the Decision on the property statement of the bank management and supervisory board members shall be amended and read as follows:

"The bank shall regularly update the data referred to in Article 2 of this Decision and submit them to the Agency in the form of an annual report no later than March 31 of the current year for the previous year."

**Article 3**

This Decision shall enter into force on the eighth day from the day of its publication in the "Official Gazette of Republika Srpska".
